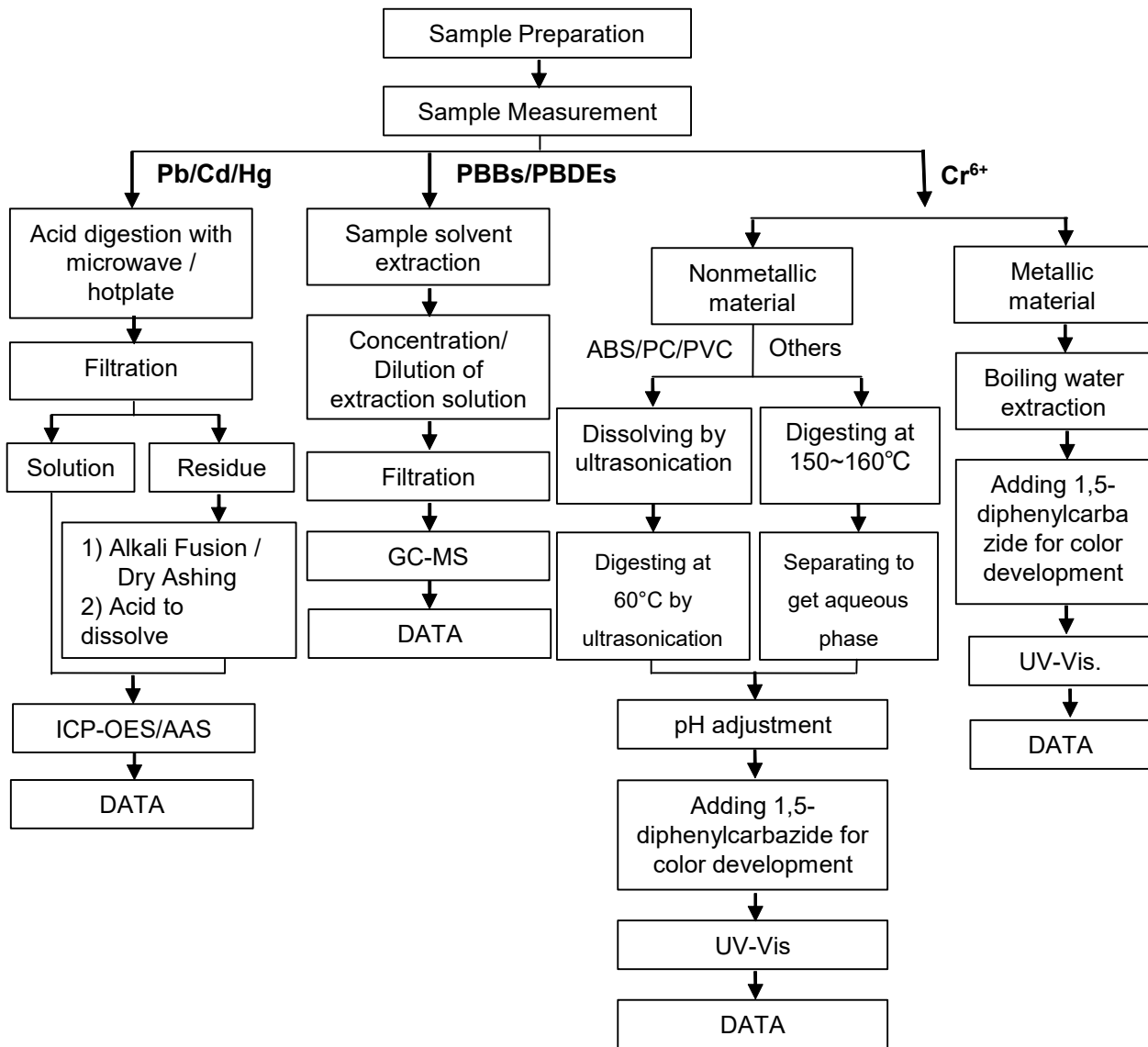

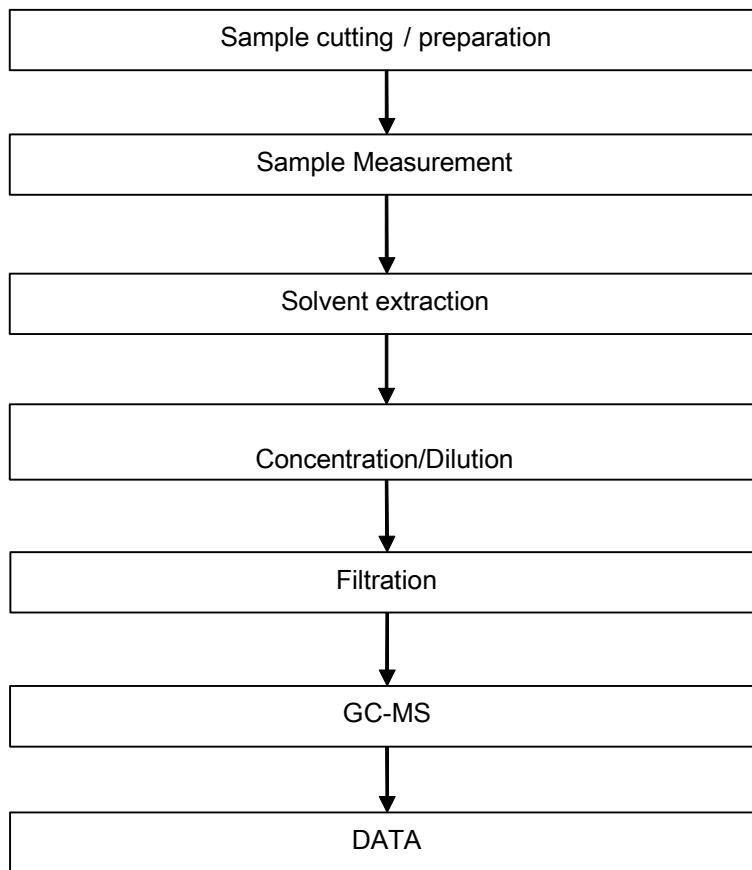

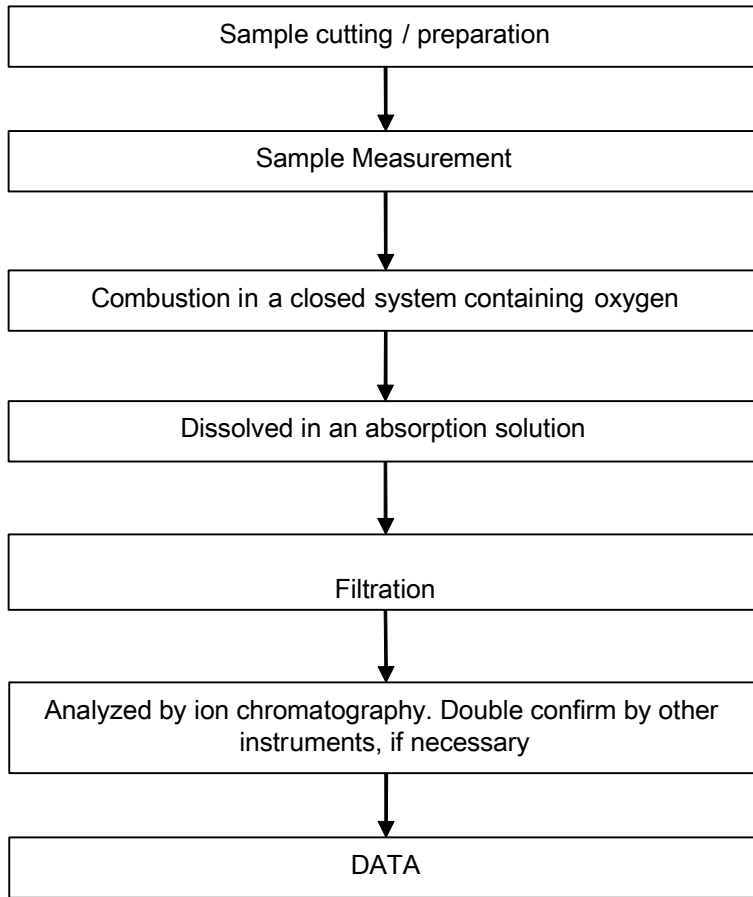
Phthalates Testing Flow Chart

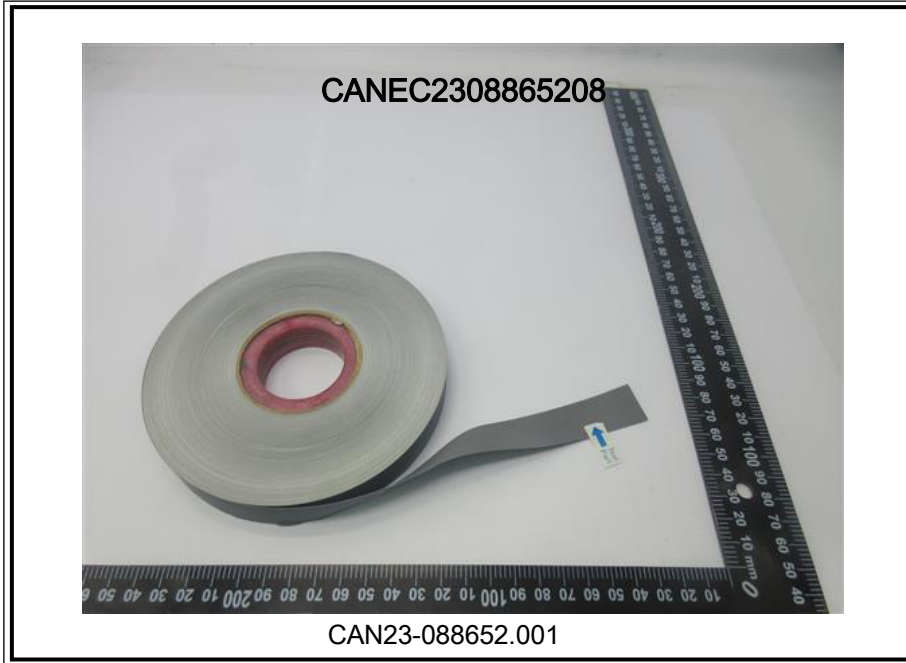
